**Privacy Notice**

**1. Information collection and purposes of collection and use.** We or our service providers collect your personal information through the Service operated and controlled by us from which you are accessing this Privacy Notice. We may ask you to submit personal information in order for your request to be completed. You will be informed what information is required and what information is optional.

We may combine the information you submit with other information we have collected from you, whether online or offline, including, for example, your purchase history. We may also combine it with information we receive about you from other sources, such as other Johnson & Johnson Affiliates, publicly available information sources (including information from your publicly available social media profiles), and other third-party information providers.

If you submit any personal information relating to another individual to us, you represent that you have the authority to do so and to permit us to use the information in accordance with this Privacy Policy.

Where any personal information is necessary for us to perform the contract, or to comply with the legal obligation, and you do not provide us with such necessary personal information for such purposes, we may not be able to perform or manage the contract, or to facilitate you.

**2. Disclosure of information:** We disclose your personal information to our affiliates for the purposes described in this Privacy Notice.
